Who are we?

North East Child Poverty Trust (NECPT) is a registered charity, established in April 2015, which is concerned about child poverty in the region and, in particular, exists to promote solutions to child poverty through collaborative working.

The founder Trustees were members of the North East Child Poverty Commission (NECPC) to support an independent charity to undertake projects which ameliorate child poverty, initially focussing on what was then known as 'holiday hunger'. NECPC is a network of voluntary organisations, charities, and statutory bodies (in particular local authorities), which campaigns for changes to national and local policy to promote greater equality and an end to child poverty. NECPC and NECPT share information and objectives but are independent of each other seeking to complement their approaches and activities.

NECPT's charitable objectives are:

To mitigate and relieve child poverty in the North East of England by:

- Raising awareness of the issue of child poverty.
- · Improving knowledge and understanding of the causes and consequences of, and solutions to, child poverty.
- · Working collaboratively with public services, voluntary bodies, employers and young people to address child poverty.

We have the following strategic objectives:

- To align with the North East Child Poverty Commission and mitigate and relieve child poverty in the region.
- To raise funds to support community based, practical activities which address and bring us closer to solving child poverty.
- · To work in partnership and deliver activities through others.

NECPT is currently entirely voluntarily run and we do not currently employ staff. Trustees are involved in different aspects of our operation.
